- Pilot Results:

There are some scale score discrepancies from 11/12. Discrepancies exist across subject areas. Test time is shorter but seems to be adequate. When using auto-locator, no one was out of range. Teachers did not need to adjust curriculum.



- Funding depends on Congress
- **DESE** is considering:
 - Bonus funding for new sites in rural areas
